**Skin Contact:** Wipe excess material from skin with a clean rag or paper towel (do NOT use solvent to clean skin). If skin contact occurs, remove contaminated clothing and wash skin thoroughly. If irritation occurs seek medical advice.

**Suitable Extinguishing Media:** Water fog (or if unavailable fine water spray), foam, dry agent (carbon dioxide, dry chemical powder).

## 6. Accidental release measures

**SMALL SPILLS:** Slippery when spilt. Avoid accidents, clean up immediately. Wipe up with rag or absorbent paper.

**LARGE SPILLS:** Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water. Cured material can only be removed by cutting or abrasion.
