Product Description: Fast-settling patch cement. A grey powder.

3. Hazards identification

Poisons Schedule: None allocated.

4. First-aid measures

5. Fire-fighting measures

Specific Hazards: Non-combustible material.

Suitable Extinguishing Media: Not combustible, however, if material is involved in a fire use: Water fog (or if unavailable fine water spray), foam, dry agent (carbon dioxide, dry chemical powder).

6. Accidental release measures

SMALL SPILLS: Sweep up, but avoid generating dust. Collect and seal in properly labelled containers for disposal.

LARGE SPILLS: Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water.

7. Handling and storage

Handling advice: Avoid skin and eye contact and breathing in dust.

Storage advice: Keep containers sealed as material may absorb moisture. Keep containers closed when not in use - check regularly for spills.

8. Exposure controls/personal protection

Occupational Exposure Limits:

Nuisance dust: 8hr TWA = 10 mg/m³

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

Avoid generating and breathing in dusts. Use with local exhaust ventilation or while wearing dust mask. Keep containers closed when not in use.

Stability: No information available.

11. Toxicological information

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

- Ingestion:** Swallowing can result in nausea, vomiting, diarrhoea and abdominal pain.

Long Term Effects:

No information available for the product. For Crystalline silica (1): Repeated or prolonged breathing of silica dust may result in chronic lung diseases such as silicosis. However, due to the particle size of the silica (sand) this is not expected to be relevant providing this product is used as recommended and good occupational work practices are observed.
